



## ICO Announcement

Happy new year everyone!

Rapidz team has made sufficient progress in business development, and the demand of RPZ coins in the market & strategic partners is very strong. Hence, we are very excited to announce our ICO and coin swap plans today!

Rapidz announced its partnership with HSBitC and the ICO plan in December 2018 to structure the ICO and strategies. We believe that our timing for the cryptocurrency market recovery is accurate and therefore decided to begin our ICO on February 11th(presale), after the Chinese New Year holidays. We aim to begin 2019 with a big bang!

One of the most unique aspects of Rapidz ICO is the acceptance of 9 different cryptocurrencies. Investors have the freedom to choose between a diverse range of cryptocurrencies to participate in the Rapidz ICO: Bitcoin, Ethereum, Ripple, Bitcoin Cash, Litecoin, XEM, Binance Coin, Huobi Token, and USDT. That is a total of 9 different cryptocurrencies including one of the top tier coins in NEM, and we also believe Binance & Huobi's exchange coins(BNB & HT) will present a very unique and exciting opportunity for our investors.

Furthermore, we have decided to swap the contributed investments into USDT daily to protect our investors against volatility during the ICO period, potentially lasting a maximum of 3 months. The USDT conversions will be processed in a transparent manner and we assure you that your assets will be safe.

- Existing holders will receive 1:200 ratio(eg. 1 old RPZ -> 200 new RPZ)
